EULab 2021 is a Summer School taking place from Friday 9 July to Wednesday 21 July with more than forty teaching hours covering 4 main modules:

Week 1

The first day of EULab 2021 (9 July 2021) will host *The Young Scholars Workshop Trafficking for the Purpose of Labour Exploitation*. Perspective participants to the Summer School and external academics and researchers under 35 years old are invited to apply to discuss crucial aspects of career development and strategies of communications of research outputs.

Monday 12 July – Friday 16 July

The lectures and seminars of the first week will address the following topics:

- i. Opening Keynote Lecture guest lecturer: Prof. Siobhán Mullally
- ii. the development of the "social dimension" of the European Union and the impact of the proclamation of the European Pillar of Social Rights and its meaning for migrant workers;
- iii. the migratory flow in the Mediterranean guest lecturer: Prof. Fabio Amato;
- iv. the fight against inequality and discrimination in the workplace;
- v. the concepts of **intersectionality** and **vulnerability** in the context of migration studies;
- vi. labour migrants' socio-ecomomic rights under international and EU law;
- vii. **political rights** of migrants [guest lecturer name to be confirmed]
- viii. labour migration in the **agricultural sector**, with a focus on the situation in Southern Europe and on the case-law of the European Court of Human Rights;
- ix. the New Pact on Migration and Asylum for labour migrants.

The first week will also host a **three afternoon workshops** which will deal with the following scenarios:

- i. the protection of migrant workers' rights before the European Court of Human Rights;
- ii. intergovernmental cooperation in the field of migrant workers' socio-economic and civil rights;
- iii. cooperation in the third sector in the field of labour migration

Lectures of the first week will be under the main responsibility of prof. F.M. Palombino, dr. G.C. Bruno e prof. F. Staiano. The names of the **invited guest lecturers** will be added to the programme as soon as they will confirm their participation.

On 15 July, the **EULab Roundtable on Labour Migration** will take place. During this event, each participant will have around 10 minutes to address an aspect pertaining the topic of the Roundtable - **The role of local authorities in the social integration process of labour migrants, with particular reference to agricultural, domestic and care workers.** The Roundtable is open to the **general public** and will be followed by an **informal discussion**.

Week 2

Monday 19 July - Wednesday 21 July

The lectures and seminars of the second week will address the following topics:

- i. the role of gender and discrimination in the domestic work sector;
- domestic workers' human rights, including their socioeconomic and labour ii. rights and the role of the prohibition of forced labour;
- challenges and reforms concerning labour migrants in the agricultural and iii. domestic work sectors during the Covid-19 outbreak;
- humanitarian corridors as a legal means of access to European countries [guest iv. lecturer – name to be confirmed];
- the management of migration issue within international organizations [guest v. lecturer – name to be confirmed];
- presentation by participants of the outcomes of the workshops. vi.

Lectures of the second week will be under the main responsibility of dr. G.C. Bruno, prof. F. Staiano and dr. G. Ciliberto. The names of the invited guest lecturers will be added to the programme as soon as they will confirm their participation.

The organization of the social events (e.g., welcome happy hour, social dinner) will depend on the restrictive measures to manage the Covid-19 pandemic.
